SUPPLY AND INSTALLATION OF A NETWORK INTRUSION DETECTION AND INTRUSION PREVENTION SOLUTION

- 1.0 The Reserve Bank of Malawi (the Bank) intends to install a Network Intrusion Detection and Intrusion Prevention solution. The Bank recognizes the importance of continuous network monitoring in order to be able to identify and prevent potential threats to its network considering the proliferation of cyberattacks with the usage of internet.
- 2.0 The Bank is therefore seeking the services of a reputable firm to supply and install a Network Intrusion Detection and Intrusion Prevention Solution. Interested firms must meet the following general conditions:
 - Should provide hardware, software licenses and professional services as a total solution. Partial solution offer will NOT be accepted.
 - Should provide a guarantee that the upgraded hardware model provided in this tender shall not be subjected to end-of-support until after at least five (5) years from the delivery date of that hardware.

- All proposed equipment must be able to function properly and reliably under the normal Controlled Environmental conditions.
- 3.0 Bidding will be conducted in accordance with open tendering procedures under International Competitive Bidding (ICB) contained in the Public Procurement and Disposal of Assets Act, 2017 and is open to all bidders.
- **4.0** Interested eligible bidders may obtain further information and inspect the Bidding Documents from the Procurement Section at the address shown in 6(a) below from 08:00 to 11:30 and 14:00 to 16:00 hours from Monday to Friday, except public holidays.
